1. What counts as personal data?
2. What personal data is particularly sensitive?
3. How do we define a harm?
4. What should the timeframe for breach notifications be?
5. What level of control should individuals have over the use and disclosure of their data and in which contexts?
6. Should consent be based on an opt-in or opt-out model?
7. Should a federal standard preempt any state laws in the US?
8. What importance does global adequacy play in developing a framework (the EU and Japan, for example, allow cross-border exchange of personal data to countries whose data protection regime have been deemed adequate to provide equivalent levels of protection)?
9. What does privacy by design look like in practice?
